ACORD4ALL

Velonetic announced in August 2022 it would continue to support standard EDI messaging (as per the specifications published on <https://www.velonetic.co.uk/blueprint-two>) as part of Phase One - Digital and that customised EDI would no longer be supported.

Responding to market feedback however, Velonetic has analysed the usage of customised EDI and has extended its market support to include a selection of more widely used customisations.

To assist market firms in planning for a successful approach to adopting phase one digital services, we are sharing below our understanding of the types of ACORD4ALL customised EDI messages your firm sends and receives, and whether we will continue to support them.

Where a message customisation is no longer supported, in many cases we have been able to recommend an alternative you may wish to consider. If you choose to do that then you have the option of requesting, via your Velonetic CRM, to receive a message in the recommended alternative format in parallel with your current version so you can compare the two.
