# **EDI Technical Spec updates**

20 November 2024

### Introduction

The details in the slides below cover the EDI Technical Spec updates for the EDI Standard messages that we will be updating to provide **an accurate view of the build.** 

- 1. There are **NO** structural changes to the EDI messages
- 2. The updates are only reflected on EDI Standard messages
- 3. The changes highlighted in the Technical specification reflect the current build
- 4. Highlighting what is not supported

The list below confirms the status as at end of October 2024. Further updates may be added.

All specs remain in DRAFT until Testing has assured the accuracy on the contents. At which point we will publish FINAL versions. All feedback on the drafts is encouraged.

#### **NEXT STEPS**

- 1. Baseline the EDIs this means DPS produces all EDIs that match the current spec at the points they are expected; then
- 2. Send the EDIs at DXC ISB to validate against production expectation
- 3. Test EDIs with vendor Vanguard
